Ground regulations Broendby Stadium

§ 1

Purpose

The objective of this Ground Regulations is to maintain the safety and security at Brøndby Stadium and to ensure that all who visits Brøndby Stadium can feel safe and secure throughout there stay as well as to ensure that all visitors feel welcome regardless skin colour, religion ore cultural background.

Brøndby Stadium is primarily used for home matches of Brøndby IF, but the stadium is also used for other purpose like other sports events and arrangements of non-sporting nature. This Ground regulations applies all arrangements, in Brøndby Stadium.

§ 2

Applicability

Ground Regulations applies the whole of Brøndby Stadiums area including entrances, exits and parking spaces, which is the available for the audience of all events in Brøndby Stadium.

§ 3

Rules for stay

At Brøndby Stadiums area only people who is in possession of tickets or access card in other way can prove, that they are entitled to stay in the area, are allowed to be present. Tickets, access card or so on shall be presented to stewards and / or the police upon request.

Spectators will take the seat which is indicated on the ticket. For Safety related reasons Brøndby Stadiums guests can be obligated to take other places, than indicated on the ticket, if this is assigned.

Visitors are not allowed to demonstrate unacceptable behaviour of any kind, or bring any harm to others or in other way bring other people in danger.

Guests of Brøndby Stadium are always obligated to abide by the rules and regulations as applicable and also follow instructions as may be given over Brøndby Stadiums amplifier and / or Brøndby IF personnel, inspectors, ambulance, police and fire brigade.

Stay at Brøndby Stadium is not allowed for visibility intoxicated persons (alcohol, drugs etc.).

Entrance Control

All visitors are required to show a ticket or other evidence available at the entrance and upon request, supply it to closer scrutiny. Proof of identity may be required to be shown on request.

Brøndby Stadiums stewards have the right to examine the guests to see if they pose a security risk due to alcohol or the influence of drugs or whether they carry weapons or other dangerous and flammable objects. The examination may be carried out either as a body search or search of items or as a combination.

The following items are not allowed at Brøndby Stadium:

- Drugs of any kind.
- Weapons of any kind.
- Items that can be used as weapons or missiles.
- Spray cans with gas, corrosive or coloring substance.
- Prams, bicycles and the like on the south stand, away section or elsewhere in the stadium.
- Bottles, beakers, cups or cans, which are made from materials which can break or shatter
- Bags with a size of 55 cm high, 40 cm wide and 20 cm deep, including sports bags, backpacks, suitcases and the like, without prior arrangement. This prohibition is Gael concerned for south stand and Away section.
- Confetti or other pressure pipes without prior authorization.
- Power driven noise instruments, for example, compressor horn.
- Food and beverages, including alcoholic beverages of any kind.
- Animals.
- Laser Pens.
- Masking objects such as hats, balaclavas and the like. All objects that are believed to be-utilized as masking, will be evaluated and will be immediately taken a position on whether it should be brought or not.
- Documents, drawings, flags or symbols of ideological or advertising purposes and / or objects that serve for commercial purposes, and as can be seen by others, or are brought for distribution among other visitors, without the prior written permission of Brøndby IF.
- Objects or items such as clothing, banners, or the like on which is printed, written or otherwise visibly expressed racial, political, criminals or other kinds of messages which could create insecurity among other.

Furthermore, it is prohibited for guests to carry out the following or the like on Brøndby Stadium to:

- climb on or over buildings and facilities including facades, fences, walls, fences of playing field, lighting, camera platforms, trees, masts of any kind or take up residence in areas not intended for general public - such as football pitch
- throwing objects that which can or may be a danger to others
- being in possession of fireworks or other kinds of pyrotechnic items
- to set off or create a fire, setting of fireworks, flares or other pyrotechnics
- to sell items or tickets, distribute printed materials and implement collections without prior permission
- to write, paint, adhesives or hang anything on the buildings, installations and advertising signs
- to administer relieve themselves outside the toilets or throw away waste
- to provoke others to hatred or violence against non-partisan, opponents or other people
- to lead or obvious wear signs and symbols of racist or violent nature as well as shouting or singing chants with this content
- to record video images or audio from any place in the Brøndby Stadium or pass on information from the match whatever terms.
- Being in possession or use of masks/balaclava or similar objects whose aim is to conceal the person's identity.

The list is not exhaustive.

For fire safety reasons, it is also forbidden guests of Brøndby Stadium to bring and / or hang banners that are not prior to the event approved by Brøndby Stadiums Safety/Security Officer.

A person who are not in possession of access card/ticket or is determined to pose a security risk or have been banned from the match, will be ejected. Expelled guests are not entitled to have their tickets refunded.

During Brøndby IF matches the whole of the south stand both lower and upper, are Brøndby IFs own territory. By staying in these areas it is forbidden to wear away teams merchandise and / or give verbal outbursts or remarks that may cause conflicts with other bystanders present. Stewards have the right to eject people who do not comply with that prohibition; however, if a safety/security assessment allows it, it is possible to be referred to other areas in Brøndby Stadium.

Furthermore, due to security risks, a prohibition against wearing the away team's merchandise (flags, shirts, scarves etc.) in other sections of the stadium, other than the away section, can be put into place at certain matches' e.g. at high risk matches etc. Notice will be given in advance. Stewards and other Brøndby Personnel permitted to eject guests who do not comply with this prohibition. The people involved will be required to dispose of or cover/hide the merchandise in question or if possible, after a specific safety/security assessment, be referred to the assigned away section.

Smoking

In all indoor locations in Brøndby Stadium applies to banning smoking. The smoking ban covers all areas where guests of Brøndby Stadium have access, including toilets, stairs and hallways.

Smoking is also prohibited in the following sections of the stadium:

- In the stalls or other sales outlets
- North stand with the exception of the visiting section
- East stand from tower 15-18 on the upper and lower level and the corner at tower 24-26 and in section 1 at the lower level.

§ 6

Liability

All access, movement and stay at Brøndby Stadium is on the visitor's own risk. Brøndby IF A/S has no liability for injuries or property damage caused by accidents or other visitor's acts or omissions.

If case of vandalism at Brøndby Stadiums property, or otherwise engage in conduct that causes Brøndby IF A/S a loss, including conduct involving the imposition of fines and / or penalties for Brøndby IF A/S, Brøndby IF A/S reserves the right to hold the person responsible for the loss.

§ 7

Special levies

Guests forcing or trying to climb the fence around the football pitch and / or otherwise obtains or attempts to gain access to the football field, despite the ban against it, see section 4 in the ground regulation, will be charged a fee of D.kr. 10,000, due and payable immediately or by specific agreement with the club.

Guests bringing or attempting to bring fireworks or other pyrotechnics, despite the ban against it, see section 4 in the ground regulation, will be charged a fee of D.kr. 5.000 due and payable immediately or by specific agreement with the club.

Guests who make use of fireworks or other pyrotechnic items, despite the ban against it, see section 4 of the ground regulation; will be charged a fee of 5.000 dkr. due and payable immediately or by specific agreement with the club.

Guests who make use/brings/wears balaclavas/masks or items to hide their identity, despite of the ban against it, see section 4 of the Ground Regulation; will be charged a fee of 5.000 dkr. due and payable immediately or by specific agreement with the club.

The throwing of any object or article, despite the ban, see section 4 in the ground regulation, will be charged a fee of 5.000 dkr. due and payable immediately or by specific agreement with the club.

Stay at Brøndby Stadium or attempt to gain access to the stadium, from persons who are banned from being present at Brøndby Stadium or Brøndby matches, despite of the prohibition, see section 4 in the ground regulation, will be charged a fee of 5.000 dkr. due and payable immediately or by specific agreement with the club.

Payment of these fines does not preclude the application of other sanctions.

§ 8

Violation of the regulations

Customers who violate internal rules can be automatically ejected and be prohibited from being present at the stadium of Brøndby IF or in any other stadium in Denmark and abroad, where Brøndby IF/Brøndby Steward corps is part of access control.

In case of an offence being a violation of national legislation such as the penal code, the police will be notified.

There may be issued a stadium/match ban from entering or being present at Brøndby Stadium or from any other venue related to Brøndby Stadium/Brøndby IF, for violations of the Ground Regulation. Similarly, offences happening in the immediate vicinity of Brøndby Stadium, such as entrances/exits, roads and walkways as well as parking places situated in the vicinity of Brøndby Stadium.
