Unless the intermediary / players' agent submitted such certificate with the DFB the season before.

The Intermediary Declaration and the criminal record clearance certificate shall be sent by mail and as original documents to the DFB, Services & Security Dept.,- Intermediaries Unit, Otto-Fleck-Schneise 6, 60528 Frankfurt.

Upon receipt and examination of all documents, the DFB Accounting Dept. is going to issue a EUR 500 invoice for the registration, which shall be duly settled by the intermediary / players' agent.
